  - o unless otherwise required by law/regulator guidance, nbn will handle your disclosure in accordance with the Whistleblower Policy.
  - o you will be subject to certain obligations, but will also be afforded certain protections, under the Whistleblower Regime, which are summarised below.
  - the protections include, 1) your identity (or any information likely to lead to your identification) will be kept confidential, unless that information is disclosed with your consent or as permitted under the Whistleblower Regime, 2) you will be protected from retaliation or detriment and 3) you will be entitled to certain immunities.
- As this form contemplates, you may make a disclosure anonymously, though this may make it more difficult for nbn
  to investigate your disclosure and to protect you against detrimental conduct.
- You should not discuss the details of your disclosure with anyone who does not need to know. Discussions with these people will not be covered by the protections in the Whistleblower Regime.
- DO NOT investigate any matter yourself. Doing so may hinder or compromise a potential investigation.
