Introduction

This document sets out the Charges and other amounts payable in connection with the **nbn**® Satellite Mobility Product.

Charges in this [Price List](#) are recurring Charges or other amounts. Recurring charges are periodic amounts payable in each Billing Period that a product or service is supplied by **nbn** to Customer. Other amounts are payable only when certain events occur (e.g. disconnections).

Part A: Recurring Charges

*Section 1 sets out the recurring Charges which apply to the Product Components which Customer must acquire as part of the **nbn**® Satellite Mobility Product. The specific Charges which apply to an Ordered Product depend on the Product Features selected by Customer (e.g. bandwidth profile).*

1. Recurring Charges

1.1 MF-VC

The recurring Charges per Billing Period for the MF-VC Product Component of the **nbn**® Satellite Mobility Product are:

MF-VC bandwidth profile	Recurring Charge
MF-VC25	\$72,360 per 25 Mbps increment ordered by Customer
MF-VC100	\$265,159 per 100 Mbps increment ordered by Customer

Part B: Early Termination Payment

*Section 2 sets out the Early Termination Payment that Customer must pay **nbn** upon certain disconnections.*

2. Early Termination Payment

- (a) Subject to section 2(d), Customer must make an Early Termination Payment calculated in accordance with section 2(b) below if:
- (i) **nbn** has commenced supplying a bandwidth profile increment of the MF-VC Product Component ordered by Customer (**Ordered Block**); and
 - (ii) **nbn** disconnects or ceases to supply that Ordered Block prior to the expiry of the Commitment Period for that Ordered Block as a result of Customer submitting a Disconnect Order (**Disconnected Block**).
- (b) The Early Termination Payment will be calculated as follows for each Disconnected Block:
- Early Termination Payment = Shortfall Period x Disconnection Monthly Recurring Charges**
- (c) In this section 2:
- (i) **Ordered Block** has meaning given to it in section 2(a)(i).
 - (ii) **Disconnected Block** has meaning given to it in section 2(a)(ii).
 - (iii) **Disconnection Date** means the date on which the event described in section 2(a)(ii) occurs in relation to a Disconnected Block.
 - (iv) **Disconnection Monthly Recurring Charges** means the total recurring Charges per Billing Period payable for the Disconnected Block as at the Disconnection Date, calculated as if the Disconnected Block had been supplied for the full duration of the Billing Period in which the Disconnection Date occurs (without any pro rata adjustment).
 - (v) **Commitment Period** means a period of 36 Billing Periods starting from the Start Date.
 - (vi) **Shortfall Period** means, in respect of a Disconnected Block, the number of Billing Periods between the Disconnection Date and the end of the Commitment Period, calculated on a pro-rata daily basis.
- (d) If Customer, on the same Product Order Form, submits a Connect Order for at least one MF-VC100 Ordered Block and Disconnect Orders for up to three MF-VC25 Ordered Blocks:
- (i) those MF-VC25 Ordered Blocks would not be considered Disconnected Blocks for the purposes of section 2(a)(ii); and
 - (ii) Early Termination Payments for the disconnection of those MF-VC25 Ordered Blocks do not apply.
