Variation Agreement for Remote Community Telecommunications

A. Background

The Remote Community Telecommunications is a specialised solution owned by the RSP used to support remote communities with enabling wi-fi and telephone services that involves the nbn equipment to be installed and maintained by the RSP.

As the equipment for the Remote Community Telecommunications are installed and maintained by the RSP, all Service Levels and Performance Objectives and Operational Targets relating to these Remote Community Telecommunications services are excluded.

B. Eligibility

To be eligible to sign this Variation Agreement, RSP must:

- (i) be a party to the Wholesale Broadband Agreement;
- (ii) be a party to the nbn® Sky Muster Plus Interim Agreement;
- (iii) be supplying RSP Product, which relies on Ordered Product as input, to at least one Remote Community Telecommunication Site; and
- (iv) be responsible for the installation and maintenance of nbn® Equipment at all Remote Community Telecommunication Sites to which the RSP supplies RSP Product.

C. Amendments

nbn and RSP agree that, on the date that the last of the parties execute this Variation Agreement, the Wholesale Broadband Agreement and nbn® Sky Muster Plus Interim Agreement between nbn and RSP are varied as follows:

(i) No Service Levels, Performance Objectives and Operational Targets will apply in respect of Ordered Product supplied to any Remote Community Telecommunication Site for as long as a site remains a Remote Community Telecommunication Site.

D. General Terms





- (i) nbn may amend or terminate this Variation Agreement by giving no less than 1 month notice to RSP.
- (ii) Unless defined in this Variation Agreement or as otherwise specified, capitalised terms used in this Variation Agreement have the meanings given to those terms in the Wholesale Broadband Agreement and nbn® Sky Muster Plus Interim Agreement.
- (iii) Clauses H4.5 (Electronic execution and counterparts), H4.10 (Governing law and jurisdiction), H4.13 (Severability) and H4.15 (Waiver) of the Head Terms of the Wholesale Broadband Agreement are incorporated into this Variation Agreement as though set out in full with references to "Agreement" being read as references to this Variation Agreement.
- (iv) The parties' accrued rights under, and the continued operation of, the Wholesale Broadband Agreement and nbn® Sky Muster Plus Interim Agreement between nbn and RSP will be otherwise unaffected by this Variation Agreement and will continue in full force and effect.

E. Definitions:

Remote Community Telecommunication Site means a location designated by nbn, or as agreed between nbn, RSP and a competent Government Agency, to be a location to be served by the Remote Community Telecommunication solution.
