

Test Description: Walk Out Working / NCD Recovery

This Test Agreement is a Standard Form of Access Agreement for the purposes of Part XIC of the Competition and Consumer Act 2010 (Cth).

- A. This document is a Test Description for the purposes of the Framework Agreement between nbn and RSP.
- B. This Test Description, together with the Standard Test Terms, forms the Test Agreement for the Test.
- C. If RSP wishes to participate in the Test, RSP must notify nbn of its intention to participate;
 - i. during the related Expressions of Interest process (if applicable); or
 - ii. after **nbn** publishes the Test Description on **nbn** website or issues this Test Description to RSP.
- D. To be eligible to participate in the Test, RSP must satisfy the following conditions (Eligibility Criteria):
 - be party to the latest version of the Wholesale Broadband Agreement and be in good financial standing under that agreement; and
 - have been selected to participate in the Test through the related Expression of Interest or other selection process (if applicable).
- E. If checked by **nbn**, the following provisions in the Standard Test Terms apply:
 - ☐ (Requirements for Test End User Contracts) clause 7(a)(iii) applies; and
 - \square (Marketing-related disclosures) clause 12 applies.

		 (b) The Test will enable RSP and nbn to work together to test a process where the nbn technician will: i. undertake an Installation to Complete an Order for nbn® Ethernet (Fibre); ii. relocate the customer's router from the FTTC-NCD to the F-NTD (with customer consent); iii. take reasonable steps to verify that the wholesale nbn nbn® Ethernet (Fibre) Ordered Product and the retail RSP fibre service appears to be activated and working; and

		(d) RSP agrees that it will not raise a Trouble Ticket in respect of an nbn® Ethernet (FTTC) Ordered Product after nbn has removed an FTTC-NCD in accordance with clause 7.1(a), and that nbn may reject or cancel any such Trouble Ticket.
		(e) RSP acknowledges and agrees that RSP is responsible for placing a Disconnect Order in respect of the relevant nbn® Ethernet (FTTC) Ordered Product after nbn has notified RSP that an FTTC-NCD has been removed under clause 7.1(c) above, and that Charges will continue to apply to the FTTC Ordered Product until it is Disconnected.
