Introduction

This document sets out the Charges and other amounts payable in connection with the Facilities Access Service.

Charges in this Facilities Access Service Price List are separated into recurring Charges and non-recurring Charges. Recurring Charges are periodic amounts which are payable in each Billing Period that a Service Element is supplied by **nbn** to RSP. Non-recurring Charges are payable only when certain activities or events occur (e.g. Co-location Activations).
