# Variation Agreement – nbn™ Sky Muster™ Plus Community Wi-Fi Product Module

## Parties

This variation agreement is entered into between:

- nbn co limited (ABN 86 136 533 741) of Tower 5, Level 14, 727 Collins Street, Docklands, VIC, 3008 (**nbn**); and

## Background

**nbn** is offering to vary the **nbn™ Sky Muster™ Plus Interim Agreement** entered into between **nbn** and Customer (**Customer's SMP Agreement**) on the terms set out in this variation agreement.

## Amendments

**nbn** and Customer agree that, on the date that the last of the parties execute this variation agreement:

- (a) Customer's SMP Agreement will be amended such that the Satellite Community Wi-Fi Module Terms of the **nbn™ Sky Muster™ Plus Community Wi-Fi Module** (as set out in the Attachment) is inserted into Customer's SMP Agreement;
- (b) any subsequent variation to Customer's SMP Agreement will not be taken to reverse or otherwise amend the amendments set out in paragraph (a) above, except where expressly set out in any such variation to the Customer's SMP Agreement; and
- (c) the parties' accrued rights under, and the continued operation of, the Customer's SMP Agreement will be otherwise unaffected by this variation agreement and will continue in full force and effect.

## General terms

Unless otherwise specified, capitalised terms used in this variation agreement have the meanings given to those terms in the Customer's SMP Agreement.

Clauses H4.5 (Counterparts), H4.10 (Governing law and jurisdiction), H4.13 (Severability) and H4.15 (Waiver) of the WBA Head Terms are incorporated into this variation agreement as though set out in full with references to "Agreement" being read as references to this variation agreement.
